# GENERAL INFORMATION AND SHOW RULES

#### ENTRY FEES

**ENTRY FEE**: for the first class in which a dog is entered is \$24.00, except Puppy classes, and Bred By Exhibitor classes, and Veteran classes, for which entry fee will be \$18.00 (including \$.50 AKC Recording Fee, and \$3.00 AKC Event Service Fee). Each additional class for the same dog is \$18.00. Junior Showmanship is \$7.00. Puppy Sweepstakes and Veteran & Altered Sweepstakes (need not be entered in a Regular Class) entry fee \$18.00. All other Non-Regular classes, entry fee is \$18.00: Brace or Team {as a Unit} and Dual Champion classes.

**NOTICE TO EXHIBITORS:** A Recording Fee of \$.50 cents and a \$3.00 Event Service fee will be required for each dog entered at any licensed or Member Club Show, Obedience Trial, or Tracking Test. This Recording Fee is to be collected by the Show giving Club and paid to the AKC. If a dog is entered in more than one class in the show, the Recording Fee is to be collected for each entry. (American Kennel Club Rule, Chapter 11, Section 2.)

**CLOSING DATE** for entries is 6:00 p.m. **Tuesday December 30, 2008**, after which time entries cannot be accepted, cancelled, or changed, except as provided for in Chapter 11, Section 6 of the Dog Show Rules. **MAIL ALL ENTRIES WITH FEES TO**: Lyn Robb, P. # NOTICE TO EXHIBITORS

**ONLY DOGS THAT ARE ELIGIBLE** to be shown under The American Kennel Club rules shall be allowed within the show precincts.

NO ENTRY shall be accepted which specifies any condition as to its acceptance.

**TO BE ACCEPTABLE** an entry must be submitted with required entry fee on an official American Kennel Club entry form.

OWNERS ARE RESPONSIBLE for errors in entry forms regardless of who may make such errors.

NO DOG WRONGLY ENTERED in a class may be transferred to another class.

**CHANGES OR ADDITIONAL INFORMATION** cannot be made by telephone. Such information must be received in writing or telegram prior to the closing of entries as published in the Premium List. **IT IS THE RESPONSIBILITY** of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of the dogs or the handlers of the dogs alone are responsible for the presence of their dog in the judging rings. This means it is not the responsibility of the ring steward nor of any agent of the show-giving club to locate any dog, its owner or handler when the dog's presence is needed in the judging ring.

**THERE SHALL BE NO DRILLING** nor intensive training of dogs on the show grounds. ALL DOGS shall be kept on leash, except when in the obedience ring.

ALL DOGS must be removed from the ring area one hour after BIS judging,

THE SHOW SECRETARY, DOG FANCIERS ASSOCIATION OF OREGON, TUALATIN KENNEL CLUB AND THE WVBC assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property, and further, assume no responsibility for injury to children. The welfare of an exhibitor or spectator's child is assumed to be the responsibility of the exhibitor or spectator. It is distinctly understood that exhibitors and spectators will exercise control and restraint over their children on the day of the Show.

**ENTRY FEES** shall not be refunded in the event that the dog is absent, disqualified, sick, lame, "in season", excused by the veterinarian or judge, or barred from competition by action of the Show Committee. If, because of riots, civil disobedience, weather relation conditions, or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made. Mail your entries with ample time for them to be delivered no later than 6:00pm on closing date, to the correct address.

Owners are responsible for errors in entry forms regardless of who may make such errors.

#### LATE, INCOMPLETE, UNSIGNED, UNPAID, CONDITIONAL ENTRIES OR ENTRIES WITHOUT FULL PAYMENT WILL NOT BE ACCEPTED AND WILL BE RETURNED TO SENDER. NO SPECIAL TRIPS TO THE POST OFFICE WILL BE MADE TO PICK UP MAIL THAT NEEDS TO BE SIGNED FOR.

# Best Bred By Exhibitor

[Competition is offered for the dogs and bitches entered and exhibited in the Bred-By Exhibitor Classes to compete for Best Bred By Exhibitor, Dogs/Bitches that win Best of Breed or Best of Winners, from the Bred By Exhibitor Class, are automatically Best Bred By Exhibitor. The dog/bitch must be handled throughout the competition by a person eligible to handle the dog/bitch in the Bred By Exhibitor Classes.]

# Non-Regular Classes (Involving Single Dog Entries)

#### Veteran Dog Class

7 Years & under 10 Years 10 Years & Older

#### **Dual Champion Dog Class**

Veteran Bitch Class

7 Years & under 10 Years 10 Years & Older

#### **Dual Champion Bitch Class**

Any dog that has been awarded the title of Champion of Record may be designated as a "Dual Champion" after it has also been awarded the title of Field Champion. The title of Dual Champion is to recognize those dogs that have shown their superiority in both adhering to the breed standard and their ability to perform the function for which the breed was developed. Classes will be judged after Winners, but before Best of Breed. **Dogs & Bitches must be intact, as First Place winner from this class will compete for Best of Breed.** 

# Non-Regular Classes (Involving Multiple Dog Entries)

**Brace Class:** For two dogs with one common owner on each dog. Dogs and Bitches may be entered in the same brace. Dogs comprising a Brace must be named at the time of entry, Specify "Brace Class" on entry form. As the judge's decision in this class will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. **Team Class:** Four dogs with one common owner on each dog. Other rules are the same as for Brace Class

#### **AWARD OF MERIT**

At the conclusion of the regular Best of Breed judging, the judge may at his/her discretion award up to a maximum of six (6) Awards of Merit, to any competitor for Best of Breed other than the final Best of Breed, Best of Opposite Sex to Best of Breed and Winners Dog and Winners Bitch. The judge is not obligated to award any Awards of Merit, if he/she feels there are not any dogs or bitches in competition worthy of this award. The total number of Awards of Merit the judge is allowed to award is dictated by the total number of Dogs and Bitches, the COUNT to include the WD and the WB, competing in the Best of Breed Competition as follows:
